**Memorandum of Understanding
Between The
United States Postal Service
And
American Postal Workers Union, AFL-CIO**

Re: General Principles on Sorting and Delivery Centers (S&DCs)

- 1) The establishment of a Sorting and Delivery Center (S&DC) will not be utilized as a reason for reducing retail operations (e.g. box sections and window services) or closing of retail units where either city and/or rural letter carrier operations have been removed.
- 2) Customers will continue to be able to pick up certified mail and other mail of attempted delivery and/or held mail at their local post offices where such mail would have been held prior to the creation of S&DCs.
- 3) Distribution and mail processing duties at the S&DC will be categorized as Function 4.
- 4) Bulk quantities of mail transported between mail processing facilities and S&DCs will be performed by Postal Vehicle Service (PVS) employees unless such work was previously subcontracted. In addition, the transportation of bulk quantities of mail to/from an S&DC to/from the retail units/box sections that letter carriers were removed from will be performed by PVS employees. The parties will continue to meet for the purpose of discussing bringing subcontracted PVS work "in house."
- 5) Management and the APWU at the national level will continue to meet and discuss issues pertaining to staffing levels, job postings and duties, (including the usage of Clerk/Special Delivery Messengers consistent with the Special Delivery Messenger/Clerk Craft Merger Implementation Procedures MOU, dated November 20, 1997), potential excessing, and issues of appropriate application(s) of Local Memorandums of Understandings, including whether or not to allow the local parties to open and discuss modifications to Local Memorandums of Understandings based upon implementing S&DCs.
- 6) At the local level, it is expected that local management will share information, as appropriate, consistent with the National Agreement, with the local union representatives related to decisions made at the national level to establish S&DCs (e.g., floor plans, timetables, parking, cafeterias, breakrooms, restrooms, public transportation, and building safety and security). In addition, the parties at the local level, will continue to fulfill their obligation under existing contract provisions relative to employees working in the newly created S & DC's.

Terms you may need to know

- RPDC
 - Regional Processing and Distribution Center aka “Super Plant” or “Mega Plant”
- LPC
 - Local Processing Center—downstream facility from an RPDC that will process mainly destinating Letters and Flats for Deliver
- S&DC (SDC)
 - Sortation and Delivery Center
 - Even if no carriers are moved in, identified offices will have remodels, SDUS installed, and called a “SDC”

Terms you may need to know

- Existing Facilities
 - ***These are buildings that are already in the USPS network—it doesn't mean they are already an SDC or an RPDC***
- New Building
 - A building that must either be built, purchased, or leased to become an RPDC or other facility
- Re-Stack
 - The taking of an “Existing Facility”, taking out machines, remodeling, adding equipment, etc. to make it a RPDC, LPC, SDC, etc

IMPORTANT NOTE

If a facility is identified to become an SDC, RPDC, LPC, etc. it does not automatically mean that it will be subject to Article 12 excessing or abolishment.

The inclusions on these lists and previously sent out documents **is not Article 12 notification of excessing!**

If and when excessing under Article 12.C.5 is to occur, your Regional Coordinator will receive notification and be in touch with affected local leadership.

Overview – S&DC Transfer Hub

Key Objectives

- Support the Delivering for America Plan
- Realign the entire network, ensuring sustainability for the USPS
- Create a route network with multiple cross dock operations

Goals

- ✓ Enhance the productivity of the local regular network
- ✓ Consolidate multiple deliveries and process exported activities at central location
- ✓ Improve building design to achieve an integrated layout
- ✓ Gain efficiencies in transportation and mail handling costs



New Term—*S&DC Transfer Hub* continued

This is not an official definition and we have not been provided one. This is simply what the USPS told the APWU.

- Mail sorted at RPDCs and LPCs will be sent to an SDC
- Cross-docked to other trucks and sent out to “downstream” facilities
- Parcels could be put onto the SDUS at one of these “S&DC transfer hubs” for additional sorting/separation
 - Would require two (2) different sort runs on the SDUS
- USPS told us that it is considered Function 4 work

The update we got on July 27, 2023, was first time these were discussed much. We asked for more explanation, the function, as well as a formal definition of a “SDC Transfer Hub”. As of today, additional information has not been provided nor have we agree to nor do we capitulate to their definition.

New Term—*S&DC Transfer Hub* continued

- You will see transfer hubs on documents shared after meeting today
- It appears many SDCs will be transfer hubs but not all of them
- Initial transfer hubs will be connected to the first RPDCs that startup

We do not have a formal definition from Labor Relations on what “Transfer Hub” means.

It is being requested but any thing in this presentation is not the APWU agreeing to or defining what the official definition is or capitulating a definition.

Current Actions

- NLRB Charges on our previously submitted RFIs
- Based on the most recent meetings and PO-408 Notices drafting new RFIs
 - Transfer Hubs
 - PO-408 Reviews/data/findings
- National Dispute has been drafted and is being finalized to be filed on the PO-408 changes/lack of negotiation with the APWU
- Tasked Regional Coordinators with working closely with locals to engage the public to participate in the Public Meetings/Comments
- Industrial Relations Department beginning visits to the SDCs/RPDCs
 - We will be contacting locals involved as visits are finalized
